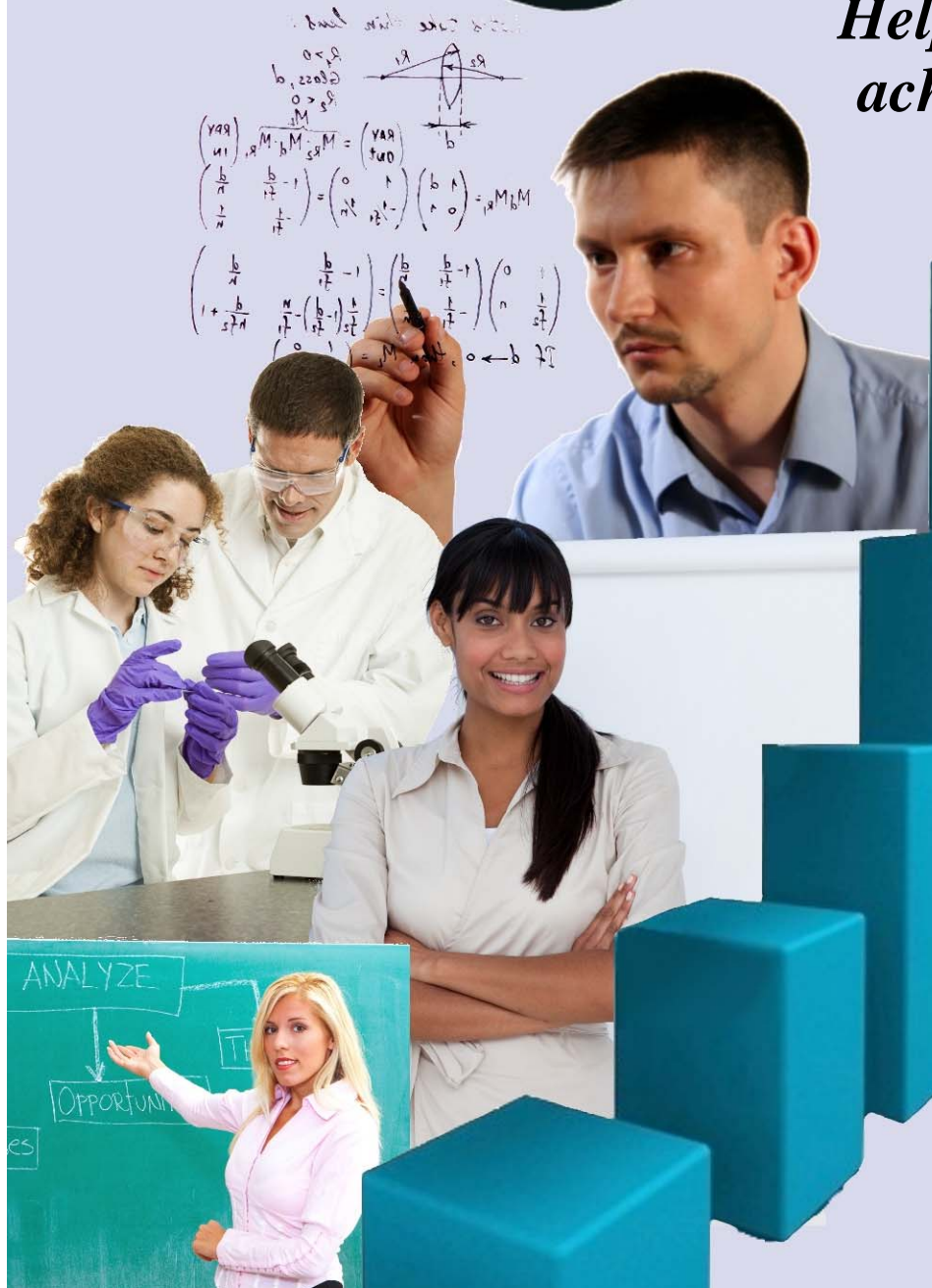

# What we do

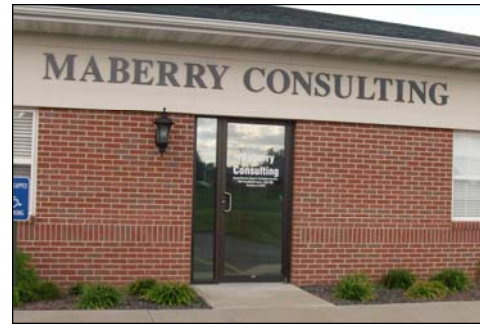

Over the years, we have developed extensive knowledge of funding sources that newcomers cannot match. We generally spend four weeks searching for the opportunities that hold the most promise for our clients. We put in the extra effort to check funders' backgrounds, and will not waste a client's resources on longshots.

Once the best opportunities are identified, we can also use our experience to prepare your proposal to meet each potential funder's unique specifications. Our turnaround time for grant proposals is typically three to four weeks. We offer a choice of payment plans to make our services more accessible to everyone. To demonstrate our investment in client relationships, if your proposal is not funded, we guarantee that we will re-work and re-submit the application for the next funding cycle at no charge.

Finally, a word of caution to newcomers: Despite claims to the contrary, grant opportunities for individuals or for-profit businesses are very limited. IRS not-for-profit status is necessary to be eligible for virtually all awards from major funders. We can prepare the State and Federal paperwork needed to achieve non-profit status. Approval can take as long as six months, but during this time we can research grant options that fit your organization.

Others submit weak proposals after asking clients to fill out a form or two, or take up so much of a client's time that they defeat the purpose of hiring a writer. Many try to bill clients based on commission as paid from a grant award, an unethical and often illegal practice that can jeopardize entire programs.
